The rate per Power Tiller is Rs. 1, 78,549/- (Rupees One Lakh Seventy Eight Thousand Five Hundred and Forty Nine) only and therefore contribution of beneficiary amounting to Rs.35, 710/- (Rupees Thirty Five thousand seven hundred and ten) only per Power Tiller is to be paid by the beneficiary in the form of Bank Draft in favour of J.K. 
