The Mini Rice Mill is provided @ 80% Govt. subsidy and 20% is to be borne by the beneficiary. The rate per Mini Rice Mill is Rs. 1,95,000/- (Rupees One lakh Ninety Five thousand) only and therefore contribution of beneficiary amounting to Rs. 39000/- (Rupees Thirty Nine thousand) only per Mini Rice Mill is to be paid by the beneficiary in the form of Bank Draft in favour of J.K Enterprise, Guwahati. The beneficiary is requested to arrange for submission of Bank Draft for Rs. 39000/- (Rupees Thirty Nine thousand) only as indicated above and approach the undersigned with 3(Three) Passport Photo copies of beneficiary and Identification proof (Voters ID) to receive the Mini Rice Mill from the company at an early date so that beneficiary can utilize the service of the Mini Rice Mill in time.

The Mini rice Mill allotted vide this order is subject to the fulfillment of the following Terms & conditions:

- 1) The beneficiary shall not transfer/sell the Mini rice Mill to another party. On detection of such cases the Mini rice Mill will be confiscated immediately without prior notice.
- 2) The beneficiary will be responsible for any damage, loss, theft, accident, etc. of the Mini rice Mill.
- 3) The beneficiary will submit the beneficiary share at the rate ascertained by the Govt. for receiving the Mini rice Mill. Non submission of beneficiary share within 7(Seven) days will lead to de-allocation of the Mini rice Mill.

The Sales Manager, M/s J.K Enterprise., Guwahati will release the Mini rice Mill to the persons authorized by the undersigned on receipt of Authorization letter from the undersigned and 20% beneficiary share from the beneficiary. He will maintain the details of the handing over of the Mini rice Mill to the authorized persons viz. Authorization letter from the undersigned, Identification proof of the authorized person, Photo of the handing over of the Mini rice Mill to the authorized person showing the name of the scheme, name of beneficiary, date of delivery, Stock Register, etc. The Sales Manager, M/S J.K Enterprise., Guwahati will have to submit receipt Challan from the authorized person stating that "the Material received with all accessories as specified and in good condition and entered in the stock register at Sl. No. and Page No." along with the aforesaid documents for submission to the undersigned for release of bank Guarantee submitted by the supplier.
