

## **GUIDELINES FOR PROMOTION OF SPORTS AMONG ST PEOPLE**

### **1. Short Title:**

This guideline may be called "Promotion of Sports among ST People and Creation of Sports Infrastructure in Tribal Areas of Assam" and will extend to the ST(P) people residing in the plain districts of Assam (outside BTC area) and to the eligible NGOs/Charitable Trusts/Registered Voluntary organizations, individual who have to undergo higher training on sports defined in the regulation of the Promotion of Sports Among ST People.

### **2. Definition:**

- i) Chairman means the Hon'ble Minister, WPT & BC Deptt., Assam.
- ii) "Registered sports organisation" means a registered organization working for the advancement/promotion of sports among ST people.
- iii) "NGO" means non-governmental organization which is a not-for-profit organization that is independent from states and international governmental organization having background of working for advancement/promotion of sports.
- iv) A "trust" means an entity created for the advancement/promotion of sports among ST people.

### **3. Major Objective of the Fund:**

To provide financial grants to NGOs/Trusts/Registered sports organizations for various initiatives such as organizing sporting events, identifying young sporting talents, providing coaching to young talents in various sporting disciplines, developing sports infrastructure and general promotion of sports among ST people in the state of Assam.

### **4. Eligibility:**

Subject to the approval of the Selection Committee, an individual/a registered sports organization/NGO/Trust will be eligible to apply in the prescribed format for financial assistance under the scheme if it fulfills the following.

- 1. Individual must be a renowned one in any sports discipline.
- 1. NGO/Trust/Registered sports organizations must be registered under Societies Registration Act of 1980 or any registered Trusts/Foundations.
- 2. NGO/Trust/ Registered sports organizations must have background of working in the field of promotion of sports and working among ST people.

### **5. Procedure for application:**

The Director, WPT & BC, Assam will widely advertize through print media about the scheme calling for applications. Applicants will apply in format prescribed for the same along with all relevant documents to the Director, WPT & BC, Assam.

## **6. Selection procedure:**

All the applications received by the Director, WPT & BC, Assam have to be in the prescribed format and shall be placed before the Selection Committee which will scrutinize the same and approve the list of beneficiaries under the scheme. Priority will be given to organizations consisting of ST members.

## **7. General:**

Grant of financial assistance under this scheme to any registered NGO/Trust/Registered sports organizations is not a matter of right. Assistance would be extended depending on the applicant satisfying the eligibility criteria and also keeping in view the financial allocation available for the purpose. The Selection Committee reserves the right to reject any application without assigning any reason thereof if the application is not found satisfactory.

## **8. Limit of Financial grant:**

The financial grant will be different for individual beneficiary. An upper limit will be Rs. 10.00 lakhs per organization is fixed for various initiatives under the scheme and the Selection Committee will approve the fund to be allotted to the organization. For sports infrastructure projects found suitable by the Selection Committee, the upper funding limit may be relaxed to accommodate the projects.

## **9. Selection Committee:**

The Selection Committee will comprise of the following members:-

- 4) In case of individual applicant certificate of achievement from competent authority must be submitted
