(vi) Generator, (vii) Stone crasher machine, (viii) Machineries for well sinking for foundation, (ix) Tripper, (x) Steel shattering and electrical license.

A contractor can be registered under this category if one executes a work value of Rs. 500.00L and declare key personnel with 2(two) Diploma Engineer(C) and 2(two) Degree Engineer(C).

Class-I(A): It is the highest level of registration of contractors. To get register under Class-I(A) category the contractor should own or lease/hire machineries (i)Truck, (ii) Concrete vibrator, (iii) Pump set, (iv) Concrete mixture machine,(v) Road Roller -8-10 ton capacity. (vi) Generator set, (vii) Stone crasher machine,(viii) Machineries for well sinking for foundation ,(ix) Tripper, (x) Steel shattering ,(xi) Pile driving machine,(xii) Excavator cum loader,(xiii) Hot mix plant,(xiv) Spot mix plant,(xv) Steel staging and electrical license. Execution of work more than Rs.500.00 L and declare key personal with 2 (two) Nos. diploma Engineer (C) and 2(two) Nos Graduate Engineer (C)
