Applications are invited from ST (P) meritorious students for "Financial Assistance" under the scheme "Special Incentive to ST (P) Meritorious Students" for the year 2022-23.Applicant will apply in the prescribed format uploaded in the official website <u>"www.directorwptbc.assam.gov.in"</u> for the same along with all the relevant documents to the office of the Directorate of Tribal Affairs (Plain), Assam, Rukmini Nagar, Dispur Last Gate, Satrinivash Path, Ghy-6 within 21st November,2022 positively if he/she fulfills the following:

- i. He / She must belong to ST (P) community of Assam.
- ii. Students must have secured 70% or above in Graduation and 65% or above in Post Graduation examination.
- iii.This incentive shall be awarded only to the meritorious students who have secured the prescribed percentage of marks or grades in the last final exam of Degree & Post Graduation, 2022.
- iv. There is no income criterion of Parents/Guardians for availing this benefit.

All applications received by the Director, Tribal Affairs (Plain), Assam will be scrutinized thoroughly and then placed before the State Selection Committee for approval of final list of beneficiaries.

Grant of financial assistance under this scheme to any ST(P) candidate is not a matter of right. Assistance would be extended depending on the applicant satisfying the eligibility and also keeping in view the financial allocation available for the purpose.
