I am directed to convey the approval of the Governor of Assam towards sanction of Rs.199.92 (L) (Rupees One Crore Ninety Nine Lakhs And Ninety Two) only as 26-Other Charges under the scheme of "One Time Special Grant for Development of ST Community" for procurement of Fertilizers (624 Metric Tons of NPK (Mixture Fertilizer) @ Rs.19,250/- (inclusive of GST, transportation etc.) per Ton and 120 Metric Ton of Zink Sulphate Hepteahydrate @ Rs.66,500/- (inclusive of GST, transportation etc.) per Ton and distribution among ST farmers during the financial year 2018-19 executed through Directorate of WPT&BC, Assam subject to availability of fund under the appropriate Head of Account and observance all financial rules, procedures, norms and formalities, issue of NIT, provision of AFR and AFRBM Act, 2005, strict compliance of CVC guidelines and submission of utilization Certificate in due course of time.

Further, the Financial sanction is subject to the following conditions:-

- 1. Director, WPT&BC shall ensure that the proposed scheme implemented properly as per rules and approved guidelines and procedures issued by Govt..
- 2. Director, WPT&BC will ensure that adherence to financial norms in vogue in the course of implementation of the scheme.
- 3. Director, WPT&BC will obtain the authentication from the Senior Most Secretary of the Department regarding the distribution list and quantity with due consultation with Agriculture Department for the chemical ground.
- 4. Director, WPT&BC shall finalize list of beneficiaries in transparent manner observing all procedure and implement the scheme in agreement with all financial norms in vogue.
- 5. Director, WPT&BC shall ensure that the tendering process has done in a transparent manner following CVC guideline by the implementing agency.
- 6. All expenditure to be incurred in observance of Assam Financial rules, various rules and procedures, notifications, issue of e-tender, CVC guidelines, various OMs of Finance Department issued from time to time during implementation of the schemes against the sanctioned amount.
- Any unspent amount shall be refunded to the Government by Treasury Challan with intimation to this Department.
- GST/Admissible Tax/IT etc. should be deducted at source and deposited in to the Treasury as per challan.

- Director, WPT&BC will submit audited statement and Utilization Certificate of current year expenditure in due course.

- 10. The Director, WPT&BC will ensure that the rate of the proposed items has been approved with constitution of financial evaluation committee as per financial rules with due consultation with FA so that certification can be made.
