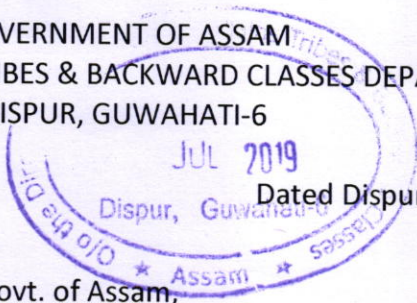

State Sponsored Scheme for Stipend to Craftsmen Training to Schedule Tribes (P) students

*****GUIDELINE*****

1. OBJECTIVE

In order provide financial assistance to poor ST students studying in various ITI institutes the scheme "Stipend to Craftsmen training to ST (P) students" have been formulated by the State Govt. as 100% State Sponsored Scheme for the benefit of students belonging to economically weaker section among ST people.

2. SCOPE

ST people living below the poverty line form a big chunk of the population and it is proposed to award scholarship to the ITI students whose parents annual income is below the poverty line.

3. ELIGIBILITY

- (a) Stipend will be awarded to students whose parents/ guardian's income from all sources does not exceed 2.50 lakhs per annum.
- (b) Students are required to have their individual Bank Account as payments will be made through DBT only.

4. DURATION AND COURSES OF STUDIES:-

The stipend shall be given to the ST students studying in various ITI institutes in the state of Assam pursuing courses like Mechanic (Motor vehicle), Electronic Mechanic, Fitters, Machinist, Electrician, Computer Operating & Programming Assistant, Basic Cosmetology or any other ITI courses as recognized by the State Government.

5. INSTITUTION OF STUDY:-

The Scholarships will be tenable only in such ITI institutions and for such ITI courses which have been duly recognized by the State Government of Assam.

6. Value of scholarship:-

The rates of Scholarships will be as under:-
Rs. 500/- per month for 10 months i.e each student will be awarded an amount of 5000/- per annum.

7. How to apply:-

The Director, WPT & BC, Assam will advertise in widely circulated print media as well as electronic media about the scheme calling for Proposals from the ITI institutes. Applicants will apply in proper format prescribed for the same along with relevant documents to their respective ITI institutions. The institutions will thereafter verify their applications and submit the proposals as per format issued from the Director, WPT & BC along with soft copies within the dateline given.
