For Students

For Institution

The Head of the institutes are hereby requested to verify the applications of the students along with their submitted documents (Caste Certificate, Income Certificate, Bank Account etc.) and submit the proposal dully filled in all columns as per prescribed format in the form of Annexure –I along with a soft copy (in excel sheet) addressing to the Director, WPT & BC, Rukmini Nagar, Dispur, Ghy-06 within 30th November, 2019 by special messenger. The format is being uploaded in the aforesaid website.
