

Applications are invited from OBC/MOBC meritorious students for "Financial Assistance" under the scheme of "Special Financial Incentive to OBC/MOBC Meritorious Students" for the year 2020-21. Students can apply in the proper prescribed format which is uploaded in the official website "[www.directorwptbc.assam.gov.in](http://www.directorwptbc.assam.gov.in)" for the same along with all the relevant documents to the office of the Directorate of Welfare of Plain Tribes & Backward Classes, Assam, Rukmini Nagar, Dispur Last Gate, Satrinivash Path, Ghy-6 on or before 12<sup>th</sup> January, 2021 positively if he/she fulfills the following:

1. Students must belong to OBC/MOBC community of Assam.
2. Students must have secured 80% or above in Matriculation and 75% or above in 10 + 2 examination.
3. This incentive shall be awarded only to the meritorious students who have secured the prescribed percentage of marks or grades in the academic year 2020-21. No claim would be considered who have qualified the examination prior to 1<sup>st</sup> January, 2020.
4. There is no income criteria of Parents/ Guardians for availing this benefit.

All the applications received by the Director, Welfare of Plains Tribes & Backward Classes, Assam will be placed before the Selection Committee which will scrutinize the same and approve the list of beneficiaries under the scheme.

**\*\*NOTE:**

Grant of financial assistance under this scheme to any OBC/MOBC Students is not a matter of right. Assistance would be extended depending on the applicant satisfying the eligibility and also keeping in view the financial allocation available for the purpose.
