ORDER

In pursuance of the Govt. sanction and approval issued vide No. FS/WPT_2020-21(I)_157, Dtd. 02-02-2021 in respect of procurement of DTP Unit, Computer World Services is instructed to supply 214 Nos. of DTP Unit consisting of Desktop PC, UPS, A3 Multi Function Printer, Voltage Stabilizer, A4 Multi function Colour Printer and Smart Phone @ Rs. 1,39,999/- (inclusive of GST and all other taxes, etc.) as per specification and rate quoted by Computer World Services against e-Tender No. DW/NIT/997/2020-21/106, Dated Guwahati, the 19th of October/2020 under the scheme Grants to One Time Special Grant for Development of OBC Community during the year 2020-21. Computer World Services is instructed to deliver the DTP Unit consisting of Desktop PC, UPS, A3 Multi Function Printer, Voltage Stabilizer, A4 Multi function Colour Printer and Smart Phone at the disposal of the undersigned. In this connection it may be stated that 2% GST (1% CGST and 1% SGST) will be deducted at source out of the total GST applicable for the item.

This order is issued simultaneously upon the signing of MoU in between Computer World Services and the undersigned or Authorized officials of this office. Computer World Services is also required to submit Security Deposit amounting to 8% of the total work order amount before 10 (Ten) days failing which this order will be cancelled. **The DTP Unit consisting of Desktop PC, UPS, A3 Multi Function Printer, Voltage Stabilizer, A4 Multi function Colour Printer and Smart Phone should be delivered to the respective Offices/beneficiaries and take a receipted challan from the incharge of the offices/beneficiaries in triplicate stating that the material with all accessories specified above are received in full and good condition with the exact quantity and quality. The names of the beneficiaries will be intimated in due course of time.**

Payment on receipt of fund from the Govt. and release of SD money will only be made by the undersigned to Computer World Services on submission of Bills and Challan in triplicate duly receipted. No escalation of rate of DTP Unit will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason. This work order is issued in accordance of Govt. sanction and payment of bills against this work order is subject to receipt of ceiling from the Govt. The undersigned will not be responsible for any delay or non-payment of bills due to non-release of ceiling from the Govt.
