ORDER

In pursuance of the Govt. sanction and approval issued vide No. FS/WPT\_2020-21(I)\_155, Dtd. 01-02-2021 in respect of procurement of Television, J.N.Trading is instructed to supply <sup>3</sup> 133 Nos. of Television @ Rs. 59,972/- (inclusive of GST and all other taxes, etc.) as per specification and rate quoted by J.N.Trading against e-Tender No. DW/NIT/997/2020-21, Dtd. 19<sup>th</sup> of December/2020 under the scheme One Time Special Grant for Development of OBC Community budgeted during the year 2020-21. J.N.Trading is instructed to deliver the Television to the destinations as per Annexure-A. In this connection it may be stated that 2% GST (1% CGST and 1% SGST) will be deducted at source out of the total GST applicable for the item.

This order is issued simultaneously upon the signing of MoU in between J.N.Trading and the undersigned or Authorized officials of this office. J.N.Trading is also required to submit Security Deposit amounting to 8% of the total work order amount before 10 (Ten) days failing which this order will be cancelled. **The Television should be delivered to the destination as mentioned in Annexure-A to the respective Offices and take a receipted challan from the incharge of the offices in triplicate stating that the material with all accessories specified above are received in full and good condition with the exact quantity and quality.**

Payment on receipt of fund from the Govt. and release of SD money will only be made by the undersigned to J.N.Trading on submission of Bills and Challan in triplicate duly receipted. No escalation of rate of Television will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason. This work order is issued in accordance of Govt. sanction and payment of bills against this work order is subject to receipt of ceiling from the Govt. The undersigned will not be responsible for any delay or non-payment of bills due to non-release of ceiling from the Govt.
