
ORDER

In pursuance of the Govt. sanction issued vide No. FS/WPT_2020-21(I)_165, Date 02-02-2021 in respect of procurement of Flour Mills (Pulverizer), Trade Supply India is instructed to supply 1011 (One thousand and Eleven) Nos. of Flour Mills (Pulverizer) as per specification and rate quoted by Trade Supply India against e-Tender No. DW/NIT/765/2019-20/1, Dtd. 19/07/2019. The Pulverizers to be supplied is of Centrifugal Products Brand Model: 3126 SP (2 HP) @ Rs. 49,437/- (inclusive of GST) per Pulverizer as per the rate approved by the Govt. vide aforementioned letter No. under the scheme One Time Special Grant for Development of OBC Community during the year 2020-21. In this connection it may be stated that 2% GST (1% CGST and 1% SGST) will be deducted at source out of total GST applicable for the item.

This order is issued simultaneously upon the signing of MoU in between Trade Supply India and the undersigned or Authorized officials of this office. Trade Supply India is also required to submit Security Deposit amounting to 8% of the total work order amount before 10 (Ten) days failing which this order will be cancelled. **The Flour Mills (Pulverizer) should be delivered to the destination as mentioned in Annexure-A to the respective Offices and take a receipted challan from the incharge of the offices in triplicate stating that the material with all accessories specified above are received in full and good condition with the exact quantity and quality.**

Payment on receipt of fund from the Govt. and release of SD money will only be made by the undersigned to Trade Supply India on submission of Bills and Challan in triplicate duly receipted from the person authorized by the undersigned stating that the material with all accessories specified above are received in full and good condition with the exact quantity and quality. No escalation of rate of Flour Mills (Pulverizer) will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason. This work order is issued in accordance of Govt. sanction issued vide letter under reference above and payment of bills against this work order is subject to receipt of ceiling from the Govt. The undersigned will not be responsible for any delay or non-payment of bills due to non-release of ceiling from the Govt.
