ORDER

In pursuance of the Govt. sanction issued vide No. FS/WPT_2020-21(I)_326, Date 11-02-2021 in respect of procurement of Power Paddy Thresher, J.K.Engineering & Agro Service is instructed to supply 401 Nos. of Power Paddy Threshers as per specification quoted by J.K. Engineering & Agro Service, Guwahati and rate quoted by J.K. Engineering & Agro Service, Guwahati and Trade Supply India against e-Tender No. DW/NIT/997/2020-21/106, Dated Guwahati, the 19th of October/2020 under the scheme One Time Special Grant for Development of OBC Community for the year 2020-21. The Power Paddy Threshers to be supplied is of BKE Brand, Model No-PTO-6 Paddy Thresher @ Rs. 1,55,558/- (inclusive of GST) per Power Paddy Thresher as per the rate approved by the Govt. vide aforementioned letter No. The 80% cost amounting Rs 1,24,446/- per Power Paddy Thresher shall be borne by the Govt. and the remaining 20% amounting Rs. 31,112/- per beneficiary shall be borne by the beneficiaries. In this connection it may be stated that 2% GST (1% CGST and 1% SGST) will be deducted at source out of total GST applicable for the item.

This order is issued simultaneously upon the signing of MoU in between J.K.Engineering & Agro Service and the undersigned or Authorized officials of this office. J.K.Engineering & Agro Service is also required to submit Security Deposit amounting to 8% of the total work order amount before 10 (Ten) days failing which this order will be cancelled. Power Paddy Threshers should be delivered to the beneficiaries on receipt of authorization from the undersigned as well as 20% beneficiary share as per instruction to be provided in due course of time.

Payment on receipt of fund from the Govt. and release of SD money will only be made by the undersigned to J.K.Engineering & Agro Service on submission of Bills and Challan in triplicate duly received from the beneficiaries or Incharge Officer of the destination offices stating that **the material with all accessories specified above are received in full and good condition with the exact quantity and quality.** No escalation of rate of Power Paddy Threshers will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason. This work order is issued in accordance of Govt. sanction issued vide letter under reference above and payment of bills against this work order is subject to receipt of ceiling from the Govt. The undersigned will not be responsible for any delay or non-payment of bills due to non-release of ceiling from the Govt.
