ORDER

In pursuance of the Govt. sanction and approval issued vide letter No. TAD/BC/185/2019/9, Dtd. 24th February/2019 in respect of procurement of Fashion Design Machine for ST women, Progressive Enterprise is instructed to supply 701 (Seven hundred One) Nos. of Semi Automatic Fashion Designing Machine (including Machine top, stand, table & Accessories) @ Rs. 14,598/- (inclusive of GST, transportation, etc.) per Machine and 701 (Seven hundred One) Nos. of Tailor Foot Fashion Design Machine (including Machine top, stand, table & accessories) @ Rs. 6800/- (inclusive of GST, transportation, etc.) per Machine as per specification and rate quoted by Progressive Enterprise against e-Tender No. DW/NIT/661/6, Dtd. 3rd of November/2018 under the scheme One Time Special Grant for Development of ST budgeted during the year 2018-19. In this connection it may be stated that 2% GST (1% CGST and 1% SGST) will be deducted at source out of 12% GST will be deducted at source.

This order is issued simultaneously upon the signing of MoU in between Progressive Enterprise and the undersigned or Authorized officials of this office. **The Fashion Design Machine should be delivered to the destination as mentioned in Annexure-A to the respective Offices and take a receipted challan from the incharge of the offices in triplicate stating that the material with all accessories specified above are received in full and good condition with the exact quantity and quality.**

In compliance of the budgeted mandate and considering the stipulated time frame fixed by the Finance Deptt. in the current financial year and the requirement of making budget expenditure against the budget provision, the undersigned will submit bills to the Govt. on the basis of MoU signed. Payment on receipt of fund from the Govt. will only be made by the undersigned to Progressive Enterprise on submission of Bills and Challan in triplicate duly receipted. No escalation of rate of Fashion Design Machine will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason.




