ORDER

In pursuance of the Govt. sanction and approval issued vide letter No. TAD/BC/164/2019/9, Dtd. 22nd February/2019 in respect of procurement of Fertilizers, Progressive Fermitech Pvt. Ltd. is instructed to supply 624 Metric Tons of N:P:K (Mixture Fertilizer) @ Rs. 19,250/- (inclusive of GST, transportation, etc.) per Ton and 120 Metric Tons of Zinc Sulphate Heptahydrate @ Rs. 66,500/- per Ton as per specification and rate quoted by Progressive Fermitech Pvt. Ltd. against e-Tender No. DW/NIT/661/43, Dtd. 4th of January/2019. The Fertilizers is to be supplied as per specification mentioned in the bid document under the scheme One Time Special Grant for Development of ST budgeted during the year 2018-19. In this connection it may be stated that 2% GST (1% CGST and 1% SGST) out of 5% GST for N:P:K and 2% GST (1% CGST and 1% SGST) out of 12% for Zinc Sulphate Heptahydrate will be deducted at source.

This order is issued simultaneously upon the signing of MoU in between Progressive Fermitech Pvt. Ltd. and the undersigned or Authorized officials of this office. **The Fertilizers should be delivered to the destination as per quantity mentioned in Annexure-A to the respective Offices and obtain a receipted challan from the incharge of the offices in triplicate stating that the materials are received in full and good condition with the exact quantity and quality.**


On completion of delivery of Fertilizers, Progressive Fermitech Pvt. Ltd. will submit Bills and Challan in triplicate duly receipted by the designated officials for onward submission to the Govt. for release of fund under ceiling system. No escalation of rate of Fertilizers will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason.

This work order is issued in accordance of Govt. sanction issued vide aforementioned Govt. letter No. and payment of bills against this work order is subject to receipt of ceiling from the Govt. The undersigned will not be responsible for any delay or non-payment of bills due to non-release of ceiling from the Govt.


