ORDER

In pursuance of the Govt. sanction and approval issued vide letter No. TAD/BC/73/2019/14, Dtd. 28th of February/2019 in respect of procurement of Drinking Water Filters for OBC families, Shree Siddha Manglam is instructed to supply 14,598 Nos. of Drinking Water Filters for OBC families @ Rs. 1370/- (inclusive of GST and all other taxes, etc.) as per specification and rate quoted by Shree Siddha Manglam against e-Tender No. DW/NIT/661/6, Dtd. 3rd of November/2018 under the scheme One Time Special Grant for Development of OBC budgeted during the year 2018-19.

In this connection it may be stated that 18% GST (1% CGST and 1% SGST) will be deducted at source out of 18% GST applicable for the item.

This order is issued simultaneously upon the signing of MoU in between Shree Siddha Manglam and the undersigned or Authorized officials of this office. **The Drinking Water Filters should be delivered to the destination as mentioned in Annexure-A and specification mentioned in the bid document to the respective Offices and take a receipted challan from the incharge of the offices in triplicate stating that the materials have been received in full and good condition with the exact quantity and quality.**

In compliance of the budgeted mandate and considering the stipulated time frame fixed by the Finance Deptt. in the current financial year and the requirement of making budget expenditure against the budget provision, the undersigned will submit bills to the Govt. on the basis of Agreement signed. Payment on receipt of fund from the Govt. will only be made by the undersigned to Shree Siddha Manglam on submission of Bills and Challan in triplicate duly receipted. No escalation of rate of Drinking Water Filters will be accommodated/ entertained by the undersigned at the time of payment of bills for any reason.






