

## MINUTES OF THE PRE-BID MEETING HELD ON 18.01.2019


A Pre-Bid meeting in respect of e-Tender floated vide No.DW/NIT/661/2018-19/43, Dated Guwahati, the 4<sup>th</sup> of January/2019 for procurement of Bio-Organic Soil enricher was held at the Conference Hall of the Directorate of WPT & BC, Assam to discuss the issues related to the tender.

The meeting was presided over by the Joint Director, WPT & BC in the presence of Deputy Director. No prospective bidders were present for the meeting and no issues were raised. However the following changes to the Tender was considered:

A certificate from bidder’s registered Chartered Accountant (CA) stating therein that the bidder has achieved a minimum average annual sales turnover of Rs.5.00 Crores during the last three financial year (2015-16 to .2017-18)”	<b>Corrigendum issued as</b> “This Invitation for Bids is open to only reputed Companies (ISO 9001: 2015 Certified)Manufacturers/ or Distributors/Dealers of Bioorganic Soil enricher having their unit offices in Assam and having minimum total annual turnover of Rs. 5.00 Crores out of the last three financial years i.e. 2015-16 to 2017-18. A certificate from bidder’s registered Chartered Accountant (CA) stating there in that the bidder has achieved a minimum total annual sales turnover of Rs.5.00 Crores during the last three financial year (2015-16 to .2017-18).
Corrigendum proposed by Director on “The bidder (s) must submit Bank Solvency certificate in favour of their firm issued by the bidder’s banker, for a minimum amount of Rs.2(Two) crores”	<b>Corrigendum issued as</b> “The bidder (s) must submit Bank Solvency certificate in favour of their firm issued by the bidder’s banker, for a minimum amount of Rs.1 (One) crores”
