NOTICE

Directorate of Welfare of Plains Tribes & Backward Classes hereby invites proposal from NGO / Voluntary Organisation / Individual for providing financial grants for the preservation and promotion of tribal culture under the scheme “**Promotion of Tribal Culture in Assam**” and will extend to the ST(P) people residing in the plain Districts of Assam (Outside BTC) for the financial year 2019-20. The proposal should includes activities relating to promotion of tribal folklore, dance, music and other art form, handicrafts, promotion of tribal food, production of documentaries, digital archiving etc. of tribal culture.

1. Individuals must be a renowned person in the area of promotion of tribal culture.
2. NGO / Voluntary Organisation must be registered under Societies Registration Act XXI of 1860 and must have background / experience of working in the field of tribal culture.
3. Priority will be given to Organisations consisting of majority ST members.
4. Those NGOs / Voluntary Organisations who have already received grants under any scheme of this Directorate for the year 2018-19 and implemented during the current year 2019-20 will not be eligible to apply.

The proposal along with relevant documents must be submitted in the office of the Directorate of Welfare of Plains Tribes & Backward Classes, Assam, Rukmini Nagar, Guwahati-6 within 30/11/2019. The proposal received by the Director, WPT&BC, Assam will be placed before the Selection Committee which will scrutinize the same and approve the list of beneficiaries. The Selection Committee reserves the right to reject any proposal without assigning any reason thereof if the proposal is not found satisfactory.

Proposals must be submitted alongwith the photocopies of the following –

- i) Up-to-date Registration Certificate of the NGO / Voluntary Organisation.
- ii) PAN Card of the Individual / NGO / Voluntary Organisation.
- iii) Copy of IT return of last three Financial Years till 2018-19.
- iv) Experience Certificate / Background of the Organisations duly certified by the Deputy Commissioner of the concerned District or by the Director of Cultural Affairs, Assam.
- v) In case of individual applicants, Certificate of achievement from competent authority must be submitted.
