





2	MODI INDUSTRIES	Technically disqualified due to following reasons i. Bank Solvency amount not given ii. Income Tax acknowledgement not given.


The Committee further approves for opening of Financial Bid of the aforementioned 16 (Sixteen) Nos. of firms found technically responsive.
